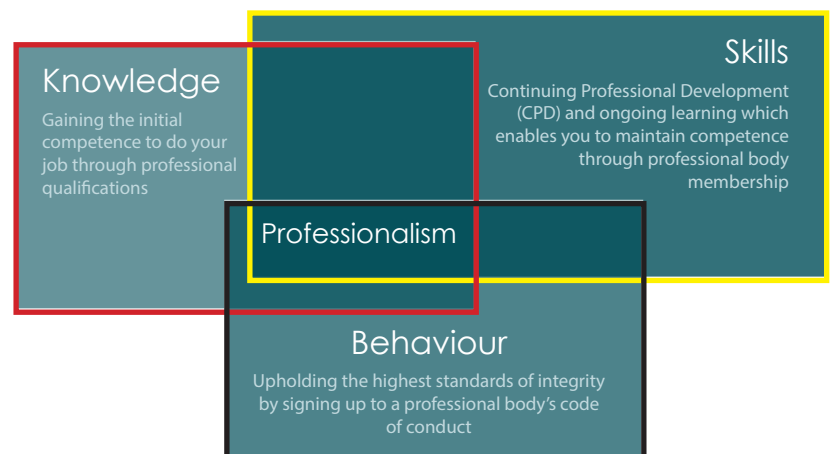

You can then complete CPD to work towards personal chartered status.
